The "PROVINCES" will in future be known as REGIONS and this will not affect the presentation of Protea colours to our anglers selected after completion of the "National/Regional" championships.

- Action:
1. On completion of the 2017 AGM the current format constitution (Version 15) will be updated to include the approved proposals/issues and circulated to all Associations.
 2. To comply with SASACC requirements the information in the current format will be transposed into the "NEW FORMAT" constitution for approval by Exco before being circulated as the new working document to the Associations.
 3. The envisaged completion date for this exercise is 31st October 2017.

18. PROPOSED CONSTITUTIONAL CHANGES:

18.1 The following proposal from Exco was unanimously accepted:

Competitive Representation (Loan Anglers) Page 10 Point 2.2.6.1

- (d) A member who nominated and was selected for any Provincial team of any Association, may not fish for any other Provincial team of any other Association during the same angling year.
- (e) In the event where an Association decides not to send a team to participate at a National Championship, **then such Association may provide list of their highest ranked anglers to SASAA, who will be available as loan anglers to other Associations. The provincial ranking of each angler shall be displayed on the list provided by the Association.**
- (f) In the event where an Association** withdraws a team from participating at such a National Championship, then any member selected to such a team, shall be allowed to fish for another Association as a "loan" angler, without the restriction imposed on them by Section 2.2.6.1 (d) above, **provided that his/her name was included in the list of available loan anglers forwarded to SASAA by his/her Association. The provincial ranking of each angler shall be displayed on the list provided by the Association.**
- (g)** A reserve selected to any team participating at a National Championship, shall also be permitted to fish as a "loan" angler without the restriction imposed by Section 2.2.6.1 (d) above, with the approval of the Executive Committee of his/her own Association, and/or SASAA , **provided that his/her name was included in the list of available loan anglers forwarded to SASAA by his/her Association. The provincial ranking of each angler shall be displayed on the list provided by the Association.**
- (h)** Members who nominated for selection to one Association, but who was not selected for any Provincial team of that Association, may **only** fish for another Association as a "loan" angler, **if his/her Association included such a member in their list of available loan anglers forwarded to SASAA. The provincial ranking of each such member must be displayed on the Association's list of available loan anglers.**
- (i)** In the event of an Association making available to another Association a "loan angler" as mentioned in paragraphs (e), (f) and (g) **and (h)** above, then Sections 2.2.6.1 (b) and (c) above shall not be applicable.

Motivation: This practise will be beneficial to the growth of the individual and complement the team making use of his services.

Fishing period: 5 hours but not less than 4 hours per day

1. The name FIPS-M cannot be used as a divisional name due to copyright restrictions.
 2. Protea colours are awarded to this facet of fishing and its imperative that the best anglers are selected by allowing all affiliated members to participate in the nationals and also growing the membership of type of angling.

18.15 The following proposal from Exco was accepted – 9 votes in favour:

Fishing Area Page 38 Point B.6.1 a

The area to be fished on any angling day shall be:

- a. **Senior A Division:**
- i) **Multiple entry points:**
 - Maximum continuous area from East to West of 16 km – min 6 km.
 - Not more than 6 km away from any entry point.
 - Swimming beaches or no fishing areas are included in the total area of 16 km.
 - ii) **Single entry point (access in both directions):**
 - Maximum total fishing area of 8 km East to West.
 - Not more than 6km in any one direction away from the entry point.
 - Swimming beaches or no fishing areas are included in the total area of 8 km.
 - iii) **Single entry point (access in one direction only):**
 - Maximum fishing area of 6 km.
- b. **Ladies, Junior, Masters, Senior B and Development Divisions:**
- i) **Multiple entry points:**
 - Maximum continuous area from East to West of 8 km – min 4 km.
 - Not more than 6km away from any entry point.
 - Swimming beaches or no fishing areas are included in the total area of 8 km.
 - ii) **Single entry point (access in both directions):**
 - Maximum total fishing area of 8km East to West.
 - Not more than 6km in any one direction away from the entry point.
 - Swimming beaches or no fishing areas are included in the total area of 8km.
 - iii) **Single entry point (access in one direction only):**
 - Maximum fishing area of 6km.
- c. **Grand Masters Division:**
- i) **Multiple entry points:**
 - Maximum continuous area from East to West of 4km – min 2km.
 - Not more than 2km away from any entry point.
 - Swimming beaches or no fishing areas are included in the total area of 4km.
 - ii) **Single entry point (access in both directions):**
 - Maximum total fishing area of 4km East to West.
 - Not more than 4km in any one direction away from the entry point.
 - Swimming beaches or no fishing areas are included in the total area of 4km.
 - iii) **Single entry point (access in one direction only):**
 1. Maximum fishing area of 4km.

Note: In the event of beach permits being obtained for vehicle access in fishing areas, the total maximum fishing area for any of the above divisions will be permitted.

Motivation: Areas were determined when vehicle access was allowed and are excessive when the current allowable mode of transport is per foot.

Shore Angling Team Selection System

Motivation: The Shore Angling System is unique to this facet as Pegged Shore Angling has its own Selection System.

18.17 The following proposal from Exco was unanimously accepted:

Selection Committees Page 42 Point C.1 a

C.1 SELECTION COMMITTEES.

a. Divisional selection committees shall be elected at the Annual Divisional Meetings, (ADM) Eligible candidates from the ranks of team management who are attending the championship, must be nominated in writing by their Member Association. Nominations to reach the Divisional Secretary before the stipulated date. To qualify, nominees for the Senior A division must have been awarded Protea or President A colours, **while nominees for all other divisions must have at least 3 years national experience.** The selection committee shall comprise:

- A convener of selectors who shall chair the selection committee **meeting. In the event of nominees for convener not being received, the SASAA representative must fulfil this position.**
- Three (3) or five (5) selectors.

Motivation: **1. The highlighted / strikethrough section be removed as it is a duplication.**
2. Selectors with experience will ensure compliance and the credibility of the selection system.
3. The same will apply as per pt. 2 above should the SASAA representative have to stand in due to non-nomination for the convener position.

18.18 The following proposal from Exco was unanimously accepted:

Selection Criteria Page 43 Point C.2.3 vii

vii FIPS-M - Only points scored in the FIPS-M Angling will be considered.

Action: This point is to be removed as it's not applicable to the Shore Angling facet but only that of Pegged Shore Angling.

18.19 The following proposal from KZN was not accepted – Only 1 vote in favour:

President B Team.

We propose that the President's B Team be selected from a one year ranking.

18.20 The following proposal from Exco was unanimously accepted:

Selection Criteria Page 43 Point C.2.5

For all other divisions (Grand Masters, u/21 & u/16) the sub group will consist of the 12 top ranked anglers. In addition to the subgroup of 12 anglers in both the u/16 & u/21 Divisions, the top 3 ranked available POC's in both (u/16 & u/21) divisions, shall be included in the pool of anglers to be considered for selection. In both (u/16 & u/21) divisions at least one (1) POC must be included in the Protea team.

Motivation: FIPS-M is not a division of Shore Angling as Pegged Shore Angling is a facet with its own selection system.

18.21 The following proposal from Exco was unanimously accepted:

Specific Selection Notes (Shore Angling) Page 44 Point C4

- 1) The **Protea** (Senior A, Ladies & u/21) and the **SA** (Masters & Grand Masters) teams selected after conclusion of the respective Divisional National Championships, shall consist of a maximum of 7 anglers, a Team Manager and or a Captain. Only the total points scored by the top six (6) anglers for these teams will be eligible as team points at the completion of the tournament.
- 2) The **Protea** (u/16) team shall consist of five (5) anglers a Team Manager and or a Captain. Only the total points scored by the top four (4) anglers will be eligible as team points at the completion of the tournament.

3) The **Presidents** (Senior A, Senior B, Senior Inland, Ladies, Masters, & Development) teams, shall consist of a maximum of 7 anglers and a Team Manager. Only the total points scored by the top six (6) anglers for these teams will be eligible as team points at the completion of the tournament.

4) The regularity of the selection of the **Protea** teams shall entirely depend on:

- i) The availability of tournaments; and
- ii) SASCOOC participation approval.

Motivation:

1. The Pegged Shore Angling criteria is applicable to the selection criteria of that facet and not Shore Angling.
2. The team size of the Presidents teams allows for an additional angler to participate and in the event of an injury the “reserve” is participating in the Gus and his points will then count for the team due to the fact that Presidents teams do not have a coach.

22. Appeal of a Dispute matter.

A member may appeal a finding of the SASAA **Dispute** Committee and refer the matter on appeal to SASAA Manco or Appeal Authority appointed by SASAA.

Where a member is not satisfied with the decision of SASAA Manco or Appeal Authority, the matter may then be referred to the SASACC **Athlete`s representative who will forward a recommendation to SASACC Manco for a decision on the matter.**

In the event where a member is still not satisfied with the decision of SASACC Manco, the matter may be referred to SRSA.

The decision of SRSA as the final Appeal Authority, will however be **final and binding**. This means thus that there is no right to appeal the ruling of SRSA as Final Appeal Authority.

Note: The guidelines and procedure of the Appeal process **in respect of a Disciplinary matter**, is contained in **PART E** of this policy.

Motivation:

1. The policy was amended at the SASACC AGM and all facets must correct their respective policies following the approval.
2. The updated policy must be included in the constitution as an Appendix/Bylaw.

18.23 The following proposal from Exco was unanimously accepted:

Code of conduct

Proposal: Excom propose that the Code of Conduct be added to the SASAA constitution as an Appendix/Bylaw.

Motivation: i) The Code of Conduct is a SASCOC requirement that all athletes are to adhere to.
ii) It is also one of requirements that must be distributed to all athletes representing South Africa or participating in a sporting event as an affiliated member of a recognised sporting Code/Association.

19. DISCUSSION OF, AND OR VOTING ON SPECIAL ISSUES:

19.1 The following proposal from Mpumalanga was discussed, but not accepted – 1 vote in favour.
SASAA to re-look at the use of Bicycles during National tournaments.

The motivation behind it is that, it is just as difficult and effort to ride a bicycle on the beach.

19.2 The following proposal from Mpumalanga was discussed and accepted – 10 votes in favour:
SASAA to vote on allowing Eel species to be claimable for SASAA records.

As it stands, Eel species are not claimable for records, but they are caught on a regular basis and do form part of the bony fish species list.

19.3 The following proposal from Exco was discussed, but not accepted – 1 vote in favour.

Proposal:

Teams participating in national championships supply their own bait with the exception of mackerel, which will be supplied by the host province. The type of bait and quantity allowed per day will still be as indicated on the invite as distributed by the host province (2 x yellowtail with max weight of 1.2kg/fish, 8 x mullet, 6 x mackerel, 1 kg chokka and 1 kg pilchard). The host province must also advise contact information of reliable bait suppliers on the invite. Teams that cannot source their own bait must notify the host province 90 days before the time and the host will then provide bait for such provinces.

Motivation:

The most important reason for this proposal is to reduce costs but still ensure the playing field is level. It is our opinion that the prices of yellowtail, chokka, mullet and mackerel is loaded. The reasoning of the price loading is as follows:

Yellowtail: The supplier quotes per fish as he does not know in advance what the weight of fish will be. He consequently quotes on 1.5kg fish. If fish of 600 – 800gram are supplied he makes a huge profit.

Chokka: It appears that big chokkas are quoted on but medium and small are supplied. Possibly the big volume is a factor and possibility of having to buy out by the supplier causes price loading up front.

Mullet: They are unreasonably priced and the only reason must be the fact that not many people have licences to supply mullet and it's virtually impossible for host provinces to obtain big volumes on their own.

Mackerel: The average price off the boat is R15/kg (+- R5/mackerel). For reasons unknown the price reaches R10 – R12.

It is our opinion that yellowtail, chokka and pilchard is readily available at cheaper prices than can be supplied by the host and that it is not difficult to throw mullets before a tournament (eg: 32 mullet/angler for a 4 day tournament).

The only bait that will cause a concern as far as levelling the playing field is mackerel, hence the proposal that the host province supply the mackerel.

The other obstacle is naturally freezing arrangements. To overcome this the host province must arrange freezing facilities at a predetermined rate as currently already in place. For the smaller tournaments of 6 man teams over 3 days there might even be enough freezing facilities in their accommodation, realising a further saving in freezing costs. The hiring of host freezing facilities is thus an optional extra should it be required.

- 19.4 The following proposal from Exco was discussed and accepted – 10 votes in favour:**
- Proposal:** Exco propose that deposits and registration of teams be processed 90 days before the tournaments and the balance be paid 30 days before. In the event of a withdrawal the deposit will be forfeited / non-refundable.
- Motivation:** This enables the host to arrange all overheads such as the functions, Scorekeeper, Lifesavers, Weigh Masters and bait timeously and will ensure that the host does not incur additional unbudgeted expenses.
- 19.5 The following proposal from Exco was discussed and accepted – 9 votes in favour:**
- Proposal:** Exco propose that at the 2018 Pegged Shore Angling Nationals all competing and eligible anglers be requested to indicate their availability for the FIPs-M World Championships in Wales (2018) and the FIPs-M World Games in South Africa (2019). The selectors are then to select both teams, in accordance with the constitutional selection criteria, taking account of the available anglers for each event. Both 2018 and 2019 teams (Men and Ladies) are to be announced following normal protocol at the 2018 Pegged Shore Angling Nationals prize-giving function.
- Motivation:** The FIPs-M World Championships in Wales takes place from 20 - 27 October 2018 and the 2019 World Games takes place from 2 – 9 February 2019. There is thus insufficient lead time between the 2018 Pegged Shore Angling Nationals and the 2019 World Games to have another National Championship to select the World Games teams. The above proposal ensures that South Africa fields its strongest available team for each individual event (e.g. the top ranked angler over 3 years following the 2018 nationals may not be available for the 2018 tournament, yet available for 2019 – he should then be selected as part of the 2019 team and not the 2018 team).
- 19.6 The following proposal from Exco was discussed and unanimously accepted:**
- Proposal:** Exco propose that the selector's criteria be added to the tournament booklet, the ADM agenda and that the SASAA Representative distributes a hard copy to the selectors for scrutiny on completion of the ADM.
- Motivation:** This will ensure transparency in the selection process to be followed and also ensure that the procedure is adhered to by all parties concerned.
- 19.7 The following proposal from Zululand was discussed and accepted – 9 votes in favour:**
ZULULAND TO ADVISE WITHIN 14 DAYS HOW THE ENVISAGED FUEL LEVY SYSTEM IS GOING TO BE CONTROLLED AND SUBMIT FIGURES FOR THE VARIOUS NATIONALS FOR THE 2017/2018 SEASON.
- Zululand Shore Angling Association would like to make the following proposal for consideration at the upcoming AGM.
- Due to changes in the venues that have been selected for the National Championships in the future, non-host provinces are being unfairly prejudiced in that their travel costs are permanently high, whereas the hosting provinces benefit from low to zero travel costs. In order to provide for a more equitable distribution of costs at National Competitions, we would like to make the following suggestion for inclusion into the competition rules.
- If we were to total the accumulated distances travelled by all the provinces, based on three vehicles per province, and divided this by the number of competing provinces, we would get an average distance travelled per province. An amount of say R2.00 per km, to be determined by the provinces annually at the AGM can be allocated and each province could be levied this amount. The resulting funds can then be paid back to the competing provinces on a pro-rata basis.
- A system such as this would ensure that no province would be unfairly prejudiced due to an inability to raise funds year on year.
- For example, if the tournament were to be held in Jeffries Bay the figures would look something like this:







SASAA het vanjaar op internasionale vlak deelgeneem in Namibië, teen Namibië (Mans, dames, o/16, o/21, meesters en grootmeesters) en dan het die mans en dames ook deelgeneem aan die wêreldkampioenskappe in Ierland. Suid-Afrika het die dames wêreld kampioen opgelewer by name Kabous Louw en het ons spanne het ook in Namibië uitstekend gevaar.

Op provinsiale vlak is die Junior- (o/16 en o/21); Ontwikkelings-; Senior B-; Meesters-; Grootmeesters-; Dames- en Senior A nasionale kampioenskappe aangebied.

Die toernooie is oor die algemeen baie goed georganiseer en was daar wynig probleme. Probleme wat wel voorgekom het is tydig opgelos maar die volgende moet aandag kry:
