## **9. PROPOSED CONSTITUTIONAL CHANGES:**

- 9.1 **The following proposals from Exco was unanimously accepted:**
  - Competitive Representation point 2.2.6.1**
    - (a) No member may represent more than one (1) Association at any **National** championship level tournament during one (1) angling year. **Only Loan anglers as defined in Sec 2.2.6.2 below shall be permitted to fish in two or more different Divisions in the same angling year. A member may however affiliate to more than any one Association for recreational purposes, but may only be affiliated to SASAA by the Association whom he wishes to represent at the annual National championships.( See 2.2.6.1 (b)(ii) below.)**
    - (b) Any angler, from any division, will have the freedom of association to represent any Association of his/her choice, provided that:
      - (i) Such angler has been affiliated to the Association of his/her choice on or before **30 April in the year of his/her selection;**
      - (ii)** The Association to which he/she affiliated to **and for which he/she wish to represent at any National championship,** had included him/her in their list of affiliated members submitted to SASAA on or before 30 April of that same year;
      - (iii) The member`s annual SASAA affiliation fee was paid in full by the Association to whom he/she nominated for selection by not later than 30 April of that same year;
      - (iv) The member must have fished at least 50 (fifty) percent of the club leagues of the Association; and
      - (v) The member must have acquired a one (1) year ranking on a point`s matrix system of his/her Association, which does not include any subjective assessment of the member to be selected.
    - (c) A member may only nominate for selection to one (1) Association in any particular angling year **as stated in (b)(ii) above.**
    - (d) A member who nominated and was selected for a team of **any** Association, may not fish for any other Association`s **team in the same Division** during the same angling year.
  - Loan Anglers point 2.2.6.2:**
    - (a) In the event where an Association **decides not to send a team** to participate at the Annual Championship, then such Association **must** provide a list of their highest ranked anglers to SASAA, who will be available as loan anglers to other Associations. The Association`s ranking of each angler **must** be displayed on the list provided by the Association.
    - (b) In the event where an Association **withdraws a team** from participating at a Championship, then any member selected to such a team, shall be allowed to fish for another Association as a "loan" angler, without the restriction imposed on them **by Section 2.2.6.1 (d)** above, provided that his/her name was included in the list of available loan anglers forwarded to SASAA by his/her Association. The Association`s ranking of each angler shall be displayed on the list provided by the Association.

- (c) **A reserve** selected to any team participating at a the Annual Championship, shall also be permitted to fish as a "loan" angler without the restriction imposed by **Section 2.2.6.1 (d)** above, with the approval of the Executive Committee of his/her own Association **and SASAA**, provided that his/her name was included in the list of available loan anglers forwarded to SASAA by his/her Association. The Association`s ranking of each angler shall be displayed on the list provided by the Association.
- (d) Members who nominated for selection to one Association, but **who was not selected for any team** of that Association, may only fish for another Association as a "loan" angler, if his/her Association included such a member in their list of available loan anglers forwarded to SASAA. The Association`s ranking of each such member must be displayed on the Association`s list of available loan anglers.
- (e) In the event of an Association making available to another Association a "loan angler" as mentioned in paragraphs **(a), (b), (c) and (d)** above, then Sections **2.2.6.1 (b) and (c) above** shall not be applicable.
- (f) An Association will only be permitted to make available a Loan Angler once their selected team has been filled with the required number of anglers.**
- (g) Only anglers who were made available by their Associations as Loan Anglers, and who were placed on the SASAA list of Loan Anglers, will be eligible as Loan Anglers to other Associations.**
- (h) In the event where a Loan Angler has been made available, and accepted by another Association, then such Loan Angler may not thereafter fish for his/her own Association in the same Tournament.**
- (i) Loan Anglers shall be permitted to fish for more than one Association in different Divisions. (See 2.2.6.1 (a) above.**
- (j) Loan Anglers from Coastal Associations, shall not be available eligible for selection of the President Inland team, but will still be allowed to retain their ranking/points obtained at any National tournament.**
- (k) The maximum number of Loan Anglers to be used by each Association shall be:**
  - **1 Angler per 3 or 4 person team.**
  - **2 Anglers per 6 person team.**
  - **4 Anglers per 12 person team.**
- (l) All Associations are required to submit a list of available Loan Anglers within fourteen (14) days after receiving notice to do so by the SASAA Secretary.**
- (m) Only anglers as described in (a) to (d) above, shall qualify as Loan Anglers to be made available to other Associations.**

**Motivation:**

- 1 - To ensure that information pertaining to Competitive Representation & Loan Anglers is separated to ensure improved understanding and control.
- 2 - To further clarify the loan angler ruling and ensure it`s clearly understood by all parties, thereby ensuring adherence of the rule by all parties.

## **9.2 The following proposal from Mpumalanga was withdrawn:**

1. If a loan angler is on the list and was selected into the team for another province, then he cannot withdraw and go and fish for his province.
2. Freedom of association - It must not be prescribed to any angler who he is or is not allowed to fish for.
3. The 12 person teams must be reconsidered. What if a province has a really bad year with anglers pulling out or whatever the case may be and require more than 3 anglers? Maybe look into making it 3-6 Anglers. But definitely not more than six.

## **9.3 The following proposal from Eastern Province was withdrawn:**

We propose that the Senior A team again consist of 13 members, of which one would have to be a person of colour, but that the top 12 scores only count or alternatively remain as is with the top 11 scores only counting toward team points.

**9.4 The following proposal Exco was unanimously accepted:**

**Pegged shore angling Page 40 pt 8 (b)**

- (1) **Senior** Male National Team to participate at FIPS-M World Championships comprising: Manager and / or captain (1) and 5 (five) anglers of which one of the anglers must be a POC.
- (2) Female National Team to participate at FIPS-M World Championships comprising: Manager and / or captain (1) and 5 (five) anglers.
- (3) **Masters National Team to participate at FIPS-M World Championships comprising: Manager and / or captain (1) and 5 (five) anglers.**

**Motivation:** To allow for Masters to compete in FIPS-M World Championships.

**9.5 The following proposal Exco was unanimously accepted:**

**Fishing area Page 45 Point B.6.1 a (1) & (2)**

- (1) **Senior A and Senior B / Development National Divisions:**
  - a) Multiple entry points:
    - Maximum continuous area from East to West of 16 km – min 6 km.
    - Not more than 6 km away from any entry point.
    - Swimming beaches or no fishing areas are included in the total area of 16 km.
  - b) Single entry point (access in both directions):
    - Maximum total fishing area of 8 km East to West.
    - Not more than 6km in any one direction away from the entry point.
    - Swimming beaches or no fishing areas are included in the total area of 8 km.
  - c) Single entry point (access in one direction only):
    - Maximum fishing area of 6 km.
- (2) **Ladies, Junior and Masters Divisions:**
  - a) Multiple entry points:
    - Maximum continuous area from East to West of 8 km – min 4 km.
    - Not more than 6km away from any entry point.
    - Swimming beaches or no fishing areas are included in the total area of 8 km.
  - b) Single entry point (access in both directions):
    - Maximum total fishing area of 8km East to West.
    - Not more than 6km in any one direction away from the entry point.
    - Swimming beaches or no fishing areas are included in the total area of 8km.
  - c) Single entry point (access in one direction only):
    - Maximum fishing area of 6km.

**Motivation:** Due to the amount of anglers participating in the combined Senior B and Development national, the fishing area needs to be increased.

**9.6 The following proposal from Exco was unanimously accepted:**

**Physical assistance - Page 46 Point B.6.4 (d)**

- (i) During competition hours, no angler shall have any physical assistance with tying knots, making traces, baiting of hooks, casting, hooking or fighting a catch. **Once a catch has been hooked, no person other than the angler may handle or touch the rod or main line of such angler whilst fighting the catch, and before the catch has been landed to such a degree that the catch is unable to return to the water on its own accord. Only the leader as mentioned in B.6.6 (e) below, may be handled or touched by any other person who is part of, or engaged in the tournament, whilst the angler is fighting such catch. The main line may only be touched to untangle it from another angler's line as mentioned in B.6.6 (e) below.** When a catch has been landed, to minimize the time the fish is out of the water a team member may assist in the unhooking and releasing.

- (ii) **In the event where an angler, whilst fighting a fish, ends up in a situation where he/she may be in danger of drowning and where such an angler is assisted by any other person(s) in an attempt to prevent him/her from drowning or return safely to shore, then such assistance shall be deemed to be physical assistance, and the fish which was landed after such assistance was given, shall be disqualified.**

**Motivation:** More clarity regarding assistance when landing a fish.

**9.7 The following proposal from Exco was withdrawn:**

Should a catch unhook or the line part, only the angler may grab or gaff the catch.

In the event where an assisting angler has a firm grasp of the catch, such angler may still land the catch, even if the hook dislodges or the line parts during the process of landing such a catch. If an assisting angler, at any stage after grabbing hold of a catch, loses his/her hold of such a catch (after the hook has dislodged or the line parted), then such assisting angler may not attempt to grab hold of or handle the catch again before it is landed, and only the angler who hooked the catch, may grab hold of, or handle such catch in an effort to land such catch. In this instance B.6.4 (d) shall still be applicable.

**9.8 The following proposal from Zululand was accepted – 11 votes in favour:**

**Gaffing aspects page 47 point B.6.6.d**

**Should a catch unhook or an angler`s line part whilst fighting a catch , then any other person(s) participating in the tournament, may grab the catch and assist in the landing of such catch, provided that no gaffing of such catch is allowed.**

**Motivation:** The angler goes through the effort and technique in raising the pull and hardship in playing the fish to the beach that every effort is made in assisting the angler land his or her fish for the better of our sport.  
In addition, this rule was implemented back when gaffing was allowed and team members would venture chest deep into the water in an attempt to gaff the fish. Today competitive anglers are not gaffing fish and rather adopting a conservational approach by bring the fish to the side and then only being assisted by team members to land the fish.  
This ruling has also lead to many controversial incidents and has influenced negatively on our sport.

**9.9 The following proposal from Exco was unanimously accepted:**

**Selection - Page 50 Point C.2.5**

Based on the 3 year ranking, a subgroup of the **21** top-ranked anglers (Senior A, Masters & Ladies) will be eligible for selection to the Protea and President sides. In addition to the above group of **21**, the 3 top ranked available POC's from the Senior A Division shall be included to be considered for selection, of which one (1) must be selected in the Protea team.

The reserve selected for the Protea side will 'automatically' be selected to the President Side.

For all other divisions (**Senior B**, Grand Masters, u/21 & u/16) the sub group will consist of the 12 top ranked anglers.

**Motivation:**

- 1 Top 18 ranked anglers was applicable when 6 man teams were selected. In the event of withdrawals of the current 7 man structure will ensure that appointments are within the 21 top-ranked anglers.
- 2 Correction as Senior B was omitted from the paragraph.

**9.10 The following proposal from Exco was unanimously accepted:**

**Selection page 52 point C.2.7**

The President Inland team **of seven (7) anglers** is to be selected **from** the **12** top ranked (over 3 years), eligible Inland anglers, **ensuring automatic selection for the top 7.**

**Motivation:** Update due to selection of seven (7) angler team.

**9.11(A) The following proposal from Mpumalanga was not accepted – only 3 votes in favour:**

**Protea & Presidents Team selection:**

1. Select the top six anglers to the Protea Team based on their 3-Year Ranking.
2. The top ranked POC angler automatically becomes the seventh angler selected, based on the 3-Year Ranking.
3. After the Protea Team is selected, the next six anglers automatically qualify for the Presidents side for Gus Kollner.
4. Should there be a withdrawal from the Protea team, the next ranked angler from the Presidents team automatically gets pulled up into the Protea team. In turn, the next best angler will be pulled up into the Presidents team based on the 3-year ranking.

**9.11(B) The following proposal from Mpumalanga was withdrawn:**

**Presidents Inland Team selection**

1. Select the President's Inland team based on the same principles as the selection of Protea and President Teams.
2. Select the top six / seven anglers from the Inland provinces automatically to the President Inland team based on their 3-Year Ranking.

**9.11( C ) The following proposal from Mpumalanga was not accepted – only 3 votes in favour:**

**All other division selections**

Use this format throughout the association's divisions (Ladies, juniors, U21 etc.) so there is no question as to who is eligible.

**9.12 The following proposal from Exco was unanimously accepted:**

**Specific Selection Notes - page 53 point C4**

- 2) The Protea (Senior A, Ladies, u/21 & **u16**) and the SA (Masters & Grand Masters) teams selected after conclusion of the respective Divisional Championships, shall consist of a maximum of 7 anglers, a Team Manager and or a Captain. Only the total points scored by the top six (6) anglers for these teams will be eligible as team points at the completion of the tournament.
- 3) The President (Senior A, Senior B, Senior Inland, Ladies, Masters, & Development) teams, shall consist of a maximum of 7 anglers and a Team Manager. Only the total points scored by the top six (6) anglers for these teams will be eligible as team points at the completion of the tournament.

**Motivation:** Update due to selection of seven (7) angler team as requested by Namibia, approved at the OGM & SGM that followed the request.

**9.13 The following proposal from Exco was unanimously accepted:**

**Coastal loan angler selection – page 53 point C4**

- 2) **Loan Anglers from Coastal Associations, shall not be eligible for selection of the President Inland team, but will still be allowed to retain their ranking/points obtained at any National tournament.**

**Motivation:** President Inland team is selected from anglers affiliated to the Inland Associations only.

**9.14 to 9.17 The following proposals from Exco were unanimously accepted:**

- a- Correction of Pegged Shore Angling selection criteria Page 55 pt D1 (a)
- b - Correction of Pegged Shore Angling selection criteria Page 55 pt D1 ( e )
- c - Correction of Pegged Shore Angling selection criteria Page 56 pt D.2.1
- d - Correction of Pegged Shore Angling selection criteria Page 57 pt D4 ( c )  
Protea **and SA**

**Motivation:** To allow for Masters to compete in FIPS-M World Championships.

## **10. DISCUSSION OF, OR VOTING ON SPECIAL ISSUES:**

- 10.1 Proposal from Mpumalanga:** SASAA to look into compensating delegates attending SASAA meetings.
- Motivation:** Meetings are only held in Cape Town and only a few associations benefit, as they do not have to travel great distances to attend.
- Outcome:** **It was decided that in future SASAA AGM will rotate between Durban, Johannesburg and Cape Town.**
- 10.2 The proposal from SASAA Exco:**
- Proposal:** SASAA intend to assist the KwaZulu Natal and Western Cape Associations with a once off funding for the junior u/16 schools league teams by paying their entry as per the invite from the host Association, for their attendance at the Junior nationals in Border during 2019.
- Reason:**
- i) SASACC have advised that the possibility of funding will only be known in November.
  - ii) Both these associations run a schools league and select a team to attend the Nationals.
  - iii) Assistance with funding is limited due to two FIPS world championships in the same financial year as well as the 2019 WC being hosted by SASAA .
- Outcome:** **Proposal was accepted.**
- 10.3 Proposal from Mpumalanga:**
- Proposal:** Gus Kollner to change back to rotating between South Africa and Namibia
- Motivation:** This tournament costs our South African anglers a fortune and it was said that Namibia would share the cost. This is not the case. We implemented the tournament and they change the rules as it suits them.
- Outcome:** **Costs are in fact split between the countries. Matter will be reviewed and Manco will advise accordingly as soon as possible.**
- 10.4 Proposal from West Coast:**
- Proposal:** Weskus hengel unie vra dat daar n special meetbord gebruik word op die klippe by Varkvlei area: ( Lat32' 46'39.93' S – Long 18'4'41.24" E ) tot Fence Northern Border (lat 32"46'39.83" S – Long 18'7'31.84" E )
- Outcome:** **It was accepted and West Coast to ensure it is stipulated in their invites.**
- 10.5 Proposal from Eastern Province:**
- Proposal:** That the Junior Nationals be fished from 8-10<sup>th</sup> January 2019 instead of 15-16<sup>th</sup> January 2019.
- Motivation:**
1. As school commence on 9<sup>th</sup> January 2019, scholars will only be absent from schools for 2 days instead of 5 days if the National is fished the following week.
  2. It is our opinion that the tides during the 2<sup>nd</sup> week of January will be also be more favourable for fishing in the East London area.
- Outcome:** **Proposal was accepted.**
- 10.6 Proposal from Mpumalanga:**
- Proposal:** Re-look at the dates for the "Senior A" nationals.
- Motivation:** It was discussed at the previous AGM that that it would be looked into that the Senior A nationals be moved to better months of the year. The "Senior A" division is supposed to be the prime of Shore Angling Fishing in South Africa, but they are not fishing at the best times.
- Outcome:** **Proposal will be submitted for the 2019 OGM and AGM due to timing constraints of the world games next year.**



#### **10.7 Proposal from Mpumalanga:**

**Proposal:** We propose to go back to the old system where all the provinces have the opportunity to host a national. This includes the inland provinces.

**Motivation:** 1 - This will give opportunity to all provinces to benefit out of the national competitions.  
2 - Traveling costs will reduce.  
3 - The past few years has proven that that the so-called "hot areas" did not produce great catches and proves that any area can have its bad days.

**Outcome:** **Not accepted only 5 in favour.**

#### **10.8 Proposal from Exco:**

**Proposal:** The 2019 Pegged Shore Angling National be postponed and take place in March 2020.

**Reason:** i) World Games / World Championships take place in Langebaan in February 2019.  
ii) Teams for the 2019 World Games / World Championships have already been selected.  
iii) The 2020 Senior & Ladies World Championships take place in France in October 2020.  
iv) The 2020 Masters World Championships take place in Tunisia in November 2020.

**Outcome:** **Proposal on hold pending the possibility of an alternative date for the national being scheduled in KwaZulu Natal.**

#### **10.9 Implementation of the travel levy:**

**Outcome:** **1 - The matter was discussed at length and finally voted on.**  
**2 – Only 5 associations were in favour, consequently the travel levy will not be implemented.**

#### **10.10 Mpumalanga proposal re implementation of fuel levy:**

**The proposal was withdrawn.**

#### **11. BUDGET 2018 FIPS MENS & LADIES (WALES) & MASTERS (PORTUGAL):**

- 11.1 Budgets accepted.
- 11.2 SASAA will subsidise the teams R 75 000 each.

#### **12. BUDGET 2018 – SA VS NAMIBIA (GALA):**

- 12.1 Budgets accepted.
- 12.2 SASAA will subsidise the teams R 40 000 each.

#### **13. NATIONAL INVITES:**

- 13.1 The respective hosts associations must ensure that final invites are submitted by: **11<sup>th</sup> August 2018.**

#### **14. 2019 WORLD GAMES:**

- 14.1 Scheduled for 8<sup>th</sup> to 15<sup>th</sup> February 2019.
- 14.2 The final brochure "2019 Shore Angling World Championship Brochure" is on the SASAA website.
- 14.3 All associations must advise their members that the selling of bait to participating teams to is not allowed as this is part of the service that SASAA has to provide as stipulated in the brochure and approved by FIPS.



### MASTERS DIVISION CHAIRMAN'S ANNUAL REPORT TO SASAA JUNE 2018

The first tournament of the new year that the Masters were involved with was the new FIPS-M Masters World Shore Angling event held in Spain in September/October 2017. The team representing SASAA was Dirk Lucas (Manager), Kallie Erasmus, Wimpie Barnard, Brian McFarlane, Eben Swanepoel and Andrew Birch with Barry Wareham as reserve/coach. After winning the practice day there was a lot of confidence in the team but the next three days proved our lack of practice and experience at this kind of fishing especially in the Mediterranean when it is warm (23-degree water). After a lot of adjustments to tackle and technical skills learnt, we managed to do very well on the 4<sup>th</sup> day, getting a 3<sup>rd</sup> position overall but unfortunately it didn't help us in the overall rankings where we came 7<sup>th</sup> out of 8 teams. The top South African angler was Wimpie Barnard followed by Kallie Erasmus at 17 and 18 respectively out of 41 anglers. The accommodation was great, the fishing not bad, but the official functions were badly organized. The next FIPS-M Masters tournament is going to be held in Portugal in November 2018.

The 2017 test series against Namibia was once again fished in Namibia with anglers based in Henties. Congratulations go out to all the teams selected and it is anticipated that their excellence in performance in the world stage will bring us winning medals and more importantly World recognition.

#### **MANDATE:-**

A lot of focus and discussion revolved around the financial stability and sustainability especially because Pegged Anglers whom represent SASAA have a huge cost burden. The participation costs per angler in the upcoming 2018 World Championships – Wales is approximately R40 000.00 according to the managers budgets, and this excludes the Protea apparel which is compulsory. The managers budgets are also based on the rand exchange rate that was stronger a few months ago and with the current economic climate we can expect the rand to weaken further, not to mention the specialised tackle that is required to fish in Wales. The change of apparel supplier by SASACC has caused further cost for the anglers in 2019, as everyone will have to purchase new Protea kits. Therefore the more accurate cost per angler including the specialised tackle can range from R55 000.00 upwards. One has to agree that this amount is equivalent to a little mortgage bond to most of us.

This was precisely a genuine concern at the Annual Divisional Meeting (ADM) and division had the following mandates for the SASAA AGM:

1. That all income and profits generated from FIP-M/Pegged Angling events only be expended to pegged angling related costs and its anglers,
2. That the anglers full Tournament Entry Fee and Flight costs be paid by SASAA for the 2018 Championships(Wales),
3. That SASAA will put in place a 7 year Strategic Plan to ensure financial sustainability to participate in the world championships.
4. That the profits from the 2019 World Games- South Africa will be directed to pay for majority of the costs that will be incurred by the Protea teams participating in this championships.
5. SASAA adopt a financial assistance plan to attract and retain managers and coaches.

#### **PROPOSAL:-**

The following constitutional addendum is proposed:

- o 3.1.1.2 (b)
  - v. Chairperson: Pegged Shore Angling

It must also be recognised that the fishing rules that pertain to Pegged Angling are unique and that the Constitution 8(a) expressly states that the National Competitions and rules will be fished as per <http://www.fips-m.org/statutes-rules-gb>

These world rules should not be mixed or confused with the current rock and surf rules, as there exists a directive from SASACC that pegged shore angling aligns itself to the international rules.

A decision was taken at the ADM that the facet needs exposure and, needs to grow and, must attract more skilled anglers, therefore the national championships was open to all individual anglers of SASAA. It has come to our notice that some Associations are “playing God” by discouraging and not allowing potential anglers that want to fish the championships. The behaviour by these associations is not doing the sport a favour and SASAA is requested to dispel this immediately.

**KZN League:-**

Recognition must be given to the Pegged Angling League that has commenced in KZN which is currently being managed by Tish Yelland, Barry Wareham and Ashwin Singh. The league has also drawn anglers from Gauteng as invites were sent to the Associations. The interest and momentum this has created is drawing more anglers into the facet and we are frequently seeing bigger interest from non-SASAA registered anglers who are being informed by social media.

I hope you see my report as a fair and accurate status of Pegged Shore Angling in South Africa.

I thereby wish all the respective National Teams in 2018/2019 the very best in their performance in the International arena.
